Attempt To Victimize Toledo Attorney Is Foiled

A 34-year-old man, who, police say, attempted to commercialize on the plot of a recently published magazine story, was held Wednesday following his arrest in a downtown office building.

Alertness of Attorney Joseph Yager, president of the National Bank of West Toledo, led to the arrest of the man, who, police say, has victimized a number of Toledo attorneys.

The man appeared at Yager's office Tuesday and told him he would like to have him handle a case for a friend who was injured in a marine accident and who was recovering in a Detroit hospital.

Yager suspected the man's story and made an appointment to see him later in the day. When the man returned he was arrested by Detective Arthur Dryer.

Police say the man has told the same story to a number of Toledo lawyers and has received small amounts in cash from several for preliminary action in the case.

COP SAVES BOY From taxideath

Stops Flow of Blood With Finger; Young Auto Victim Is Recovering

A 9-year-old boy who was run over and injured seriously Tuesday by a taxicab near the Interurban station owed his life Wednesday to a policeman who, with his thumb, stopped the flow of blood from a severed artery.

The victim, Walter Reddick, 9, of 39 S. Michigan street, was recovering Wednesday in his home.

The accident was witnessed by Patrolman Peter Rubel, who dragged the boy from beneath the wheels of the taxicab.

STOPS BLOOD STREAM.

Noticing that an artery near the boy's temple, on the left side, was severed, Rubel pressed his thumb tightly against the victim's head to stop the flow of blood.

He then ordered the taxicab driver, Harold Koepplinger. 818 Main street, to speed to County Branch hospital. Attendants there said the patrolman's prompt action probably saved the boy from bleeding to death.

He had a severe gash on his head and was injured about the shoulders.

NOTIFIED BY PEDESTRIANS.

Koepplinger told police he had not seen the boy until pedestrians shouted to him that the victim was under the wheels of his car. The accident occurred as the taxi driver was pulling into the taxi zone near the station. He was directly behind a large bus that had unloaded passengers.

Mrs. Nellie Scaright, 22, of 1015 Western avenue, was bruised at 9 p. m. Tuesday when an auto in which she was riding with Charles T. Scaright collided with another car which failed to stop after the accident. The mishap occurred at Western avenue and Hawley street.





"TOUGHS" WEEP WHEN BANDITRY ENDS IN COURT

Boy Robbers Lose Braggadocio as Judge Sends Them to County Jail

FACE BLEAK HOLIDAY

One Youth Probated Out of Pity for Mother Who Pleads for Son

Braggadocio melted and the romance of banditry fided into a mist of hot, bitter tears when a group of youthful outlaws found themselves at the end of the chapter in juvenile court.

Two 14 and 15-year-old vandals who looted and destroyed \$300 worth of property in Lagrange school Dec. 4, will eat Christmas and New Year dinners in County jail.

At the end of that time they may be sent to the industrial school.

The elder boy began his criminal career in 1929. In a vain effort to control him, his mother told the court she had hidden his clothes and made him wear dresses to keep him at home.

PITY SAVES ONE.

Pity for a widowed mother saved a 16-year-old boy, one of a gang of six, from serving a reformatory sentence. The gang confessed to looting a number of Dorr street stores. The mother twice suffered heart attacks and had to be carried from the room. Fearing execution of the sentence would prove fatal to the mother, the court suspended the term, paroling the lad to Attorney Albert Miller.

Two of the gang appearing in court for the first time were probated to City Detective Fred Palicki at his own request.

The leader is to be bound over to the grand jury, while the others are to be held in jail until Jan. 5, when they may be probated.

FAMILY MOVES AWAY.

One family was preparing Thursday to move to Fremont, O., to keep a 16-year-old son away from a gang which lured him into banditry.

The boy, oldest of seven children, pleaded guilty to burglarizing several East Side homes.

A joyless termination to a joy ride came when four boys, ranging from 12 to 15 years old, were sentenced to the Boys' Industrial school at Lancaster, O., following the theft Nov. 29 of a car owned by Arthur Welsh, 523 Oak street. The boys returned the car a few hours later.

SENTENCE SUSPENDED.

Sentence was suspended and the youths probated to Zachary T. Jones, juvenile official.

A lad whose higher education ceased abruptly when his pants gave out, convulsed court attendants when he appeared on a charge of truancy.

"I can't go to school," he said, "because I've only got one pair of pants and they came out of the ark!"

If his parents are unable to provide the important garment, e charitable agency in the city will do so.

The Toledo News-Bee - Dec 12, 1929 PLAN TO SLOW TRAFFIC KILLED AS UNFEASIBLE

Council Committee Tables Bill To Extend 20-Mile Speed Limit District

The plan of slowing traffic in the outlying districts of the city by extending the official congested area district, as conceived by a city council subcommittee appointed to investigate relief from present traffic conditions, was tabled by the committee Wednesday night after Safety Director Archibald D. Black and Traffic Inspector Thomas O'Reilly declared the plan unenforceable and not feasible.

O'Reilly declared the plan could be enforced only by increasing the force of motorcycle police. The same effect could be obtained without the law, O'Reilly declared, if enough police were available to patrol the thru streets of the city. Black said he would suggest more motor patrolmen in his report to be submitted at the end of the year. The present congested zone is

bounded by Cherry, Michigan and Monroe streets, where under state law the speed limit is 20 miles an hour. Outside the area it is 35 miles.

O Reilly said the large number of auto fatalities can be laid directly at the door of the high speed law.

Man Who Shot Himself When Chased by Deputies Identified

Detective Frank DeLora announced Monday that the man who shot and killed himself near Fremont late Friday as he was being pursued by deputy sheriffs had been identified as a resident of Point Place.

DeLora said a photo of the slain man was identified by persons from whom the man purchased a bungalow in Point Place and by several officials of a Toledo boathouse who knew him.

MAN DISAPPEARS.

According to DeLora, the man bought the house in Point Place three years ago and had lived there until three months ago when he disappeared with another Point Place man. He also owned a launch, De Lora said.

Residents of Point Place said they knew nothing of the man's past. They were positive, however, in their identification.

Early last May the man dug up the skelton of a child along the Maumee river. Coroner Frank G. Kreft said the chil dhad been dead 40 years.

The man ended his life in Dewey Woods after he had fled from deputy sheriffs who followed his auto when he failed to stop or a traffic light in Fremont.

DROVE STOLEN CAR.

The auto he was driving is said to have been stolen Oct. 25, from Fairview, Pa.

In addition to the revolver with which he shot himself, he carried another revolver, several hundred rounds of amunition and a watch.

Finger prints of the man were to be sent to Toledo Saturday to aid in verifying the identification.

DeLora said the man is believed to have been in Toledo last week.



Three West End Homes Robbed **During Night: Plunder Worth** \$3000 Recovered

One of two burglars who looted three West End homes of clothing and jewelry worth \$3000 early Saturday is believed to have been shot by William G. Nagel Jr., whose home at 424 Winthrop street was the last visited by the prowlers.

The other homes robbed were those of C. R. Brand at 2835 Parkwood avenue and Otto Heinzerling at 420 Kenilworth avenue.

WIFE SEES INTRUDER.

Nagel was awakened by his wife at 6 a.m. Saturday when Mrs. Nagel awoke to gaze in horror at a man who was entering their bedroom thru a door from the hallway. Mrs. Nagel saw, the intruder flash a light about the room, then pick up a pair of Nagel's trousers and take a pocketbook from a pocket. The pocketbook contained \$50.

Believing that the man might harm her husband or take her valuable diamond rings if she screamed, Mrs. Nagel employed a subtle ruse to frighten the burglar. A sleepily muttered "I'm cold, I think I'll get a blanket," caused the man to flee. She ran to the bedroom door, closed it after him, and awakened her husband.

Nagel seized a revolver from a The Toledo News-Bee - Dec 21, 1929 dresser drawer and ran to the rear door of the house in time to see the prowler leaving the yard, his arms piled high with clothing taken from the Nagel home.

SHOOTS TWICE.

Nagel shot twice at the prowler as the man disappeared into an alley. He then called police. The man is believed to have had a companion.

In the 200 block of Columbia street the detectives saw a man who answered the description of the prowler at whom Nagel shot. When they called to the man, he fled bctween houses and leaped over a fence. Coghlin shot at him four times.

ONE BELIEVED SHOT.

This led police to believe that one of the bullets fired by Nagel had struck the prowler, altho no blood was found there.

The prowl of the Nagel home climaxed a busy two hours for the burglar or burglars.

They first visited the Brand home and ransacked the home of \$2500 in tewelry taken from a bedroom in which Brand and his wife slept. From a dresser drawer in the room they took \$10 and downstairs they seized two watches and a fountain pen, wrapped in Christmas packages and ready for mailing.

STEAL NEW SHOES.

A woman's purse on a chair nearby was ignored when the prowlers found it to contain no money.

Perry is survived by four sons. Earl A., Detroit; Raymond D., and Martin, Toledo, and Orlow D., Cleveland; three daughters, Mrs. H. A. Brown, Cleveland; Mrs. John Davies and Miss Lulu Perry.

Services will be at 2 p. m. Thursday from Eggleston's funeral home. Burial will be in Woodlawn cemetery.

ENRAGED MAN Kills Pal, Dies Fighting Cop

Shoots Himself in Struggle With Policeman for Possession of Revolver

FAMILY QUITS HOUSE

Many Years' Friendship Ended in Double Tragedy Christmas Day

A lonely and unlighted litt • Christmas tree, decked by laughir a children's hands, stood as a trag: symbol Thursday to a double slag ing, which death chose as an iron: Christmas day gesture for two drvoted friends.

The tree and a little heap of toyabandoned in grief by the three terror-stricken children of these men, looked out forlornly from " bullet-shattered window in the home of Paul Smith, 38, at 845 Collins street, where early on Christme" morning Smith shot and killed hos friend, Edward Shofner, 43, in the first quarrel the men had had in a lifetime of friendship.

VERDICT RETURNED.

In a verdict of homicide and accidental death, brought Thursday by Coroner Frank G. Kreft, all official investigation of the tragedy had ended. The coroner said that Shof ner was shot to death by Smith and Smith was killed when a revolver he trained on Patrolman Leonard Mills in resisting arrest was twisted in his hand by the patrolman, the bullet striking Smith in the head.

The coroner, by his verdict, cleared the policeman of all blame in the shooting.

The coroner's verdict ends the case, but it does not tell of the drama behind the double tragedy. It does not explain why two friends who for many years had been inseparable and harmonious should sit almost in the shadow of a Christmas tree they had helped trim and argue with such intensity that death climaxed the dispute.

CHILDREN HEAR QUARREL.

The fatal quarrel was overheard by the three children, who had awakened early on the holiday in anticipation of seeing the tree and receiving their presents. The children were Smith's son and daughter, John, 14, and Dorothy, 10, and Billie, the 8-year-old son of Stofner. Last May, after Billie's mother died, the little boy and his father went to live with the Smiths.

The two men, who came to Toledo together from Shelbyville. Tenn., with their families seven years ago, had sat up far into the night listening to the radio and talking.

One of the children, who was awake when the shooting occurred, heard the words, "You can't talk to me like that," spoken shortly before three shots rang out on the cold night air.

When Patrolmen Mills and Joseph Rosenthal arrived at the scene, Shofner was lying on the sidewalk in front of the house, dead. Smith was standing in the doorway. As Mills approached him, Smith raised a small revolver menacingly.

BULLET ENTERS HEAD.

Mills ignored the threat and dived headlong for the gun wielder. He seized Smith's wrist and forced the revolver away from him as the weapon was discharged. Both men tumbled to the floor of the house and Mills arose to find a bullet wound in Smith's forehead.

Smith was taken to Robinwood hospital but did not regain consciousness. He was booked on suspicion at the Safety building at 2:12 a. m. Wednesday, but died at 10:20 o'clock the same morning.

Mrs. Smith was awakened by the shots. The children, Johnny and Dorothy, and Billie, also were aroused by the sounds of the men arguing in the living room, but were unable to tell police any words that passed between the two except the one remark, "You can't talk to me like that."

RECONSTRUCT SCENE.

The voice, the children believed, was that of Smith.

Police believe that, enraged over some petty difference of opinion. Shofner decided to leave the home of the man who had comforted him in his bereavement and shared his home with him.

They believe that Smith followed Shofner to the door and that when he saw his friend was sincere in leaving the Smith home, his temper, typical of the mountains of Tennessee from which he and Shofner came to Toledo together to make their way, overwhelmed him and that he shot down his chum.

Coroner Kreft said he had been informed that both Smith and Shofner had been drinking before their argument started.

No weepon was found on Shofner.

SUSPECTS HELD For Burglaries

Two Men Believed To Have Entered 40 Homes in Last Month

Two suspects, believed to be the hurglars who have terrorized West Toledoans by a series of robberies in which they have obtained several thousands of dollars' worth of loot, were held Thursday.

One of the suspects was captured after a chase by Patrolmen Frank Richter and Anthony Majchzak, who were investigating a complaint of an attempted burglary of a garage at the rear of the home of F A Rosenberger, 2703 Robinwood avenue.

The patrolmen saw the man running away from the garage and pursued him to an alley near Scottwood avenue, four blocks away. Threatening to shoot, the policemen stopped the fugitive and arrested him. A revolver was found in the man's pockets.

The suspect admitted the attempt to burglarize the garage. He implicated another man, police said, and the other suspect also was arrested.

The suspects are believed to be the men who have entered nearly two score West End homes in the last-month.

RETIRED POLICEMAN. CAPTURES PROWLER

Overpowers Man He Finds Trying To Open Door of Home

A burglar whose oratorical propensities surpass his skill in prowling, occupied a cell at the Safety building Thursday because he tried to rob the house of a retired city patrolman at 11:30 p. m. Christmas.

Cecil Cook, 228 Field street, who has lost none of his cunning in the six years he has been retired from active duty as a patrolman, captured the man while the prowler was tampering with the lock on the front door of his home.

Cook and his family were entertaining guests in another part of the house when the retired policeman heard a noise on the front porch. He walked stealthily thru the darkened front room, peered out a window and saw the prowler busy at the door.

He suddenly threw open the door and seized the prowler, dragging hum into the house.

The man insisting he could speak eight languages, was taken to the Safety building, where he is held on a technical charge of suspicion.

2 ROBBER SUSPECTS CONCEAL IDENTITIES

Fouths Believed Perpetrators of Burglaries in City.

An effort was to be made Friday to identify two youths, one 18 and the other 21, held in the Safety building on suspicion as the burglars who have been invading homes in the west end.

The suspects were arrested at 2:15 , m. Friday at Nesslewood and Robngwood avenues by Patrolmen Leonard Mills and Joseph Rosenthal who last Sunday morning fired at , prowler whom they found loiterng in the same neighborhood.

G. W. Nagel, 424 Winthrop street, who fired at burglars who invaded his home last week, will view the suspects.

JUDGE TELLS WHY HE FREED PISTOL TOTER

Suspended Sentence Is Given Kriess Because No Gun Was Found on Him

POLICE FIND REVOLVER

<u>Officer Says He</u> Saw Suspect Throw Something Away During Flight

Statements were made from three sources Monday to explain why a 23-year-old former reformatory prisoner was given only a 30-day suspended sentence by Judge Homer Ramey in police court Saturday after he had pleaded guilty to a charge of carrying concealed weapons.

The prisoner was Clayton Kriess. 3936 Leybourne avenue, who a year ago was sentenced to the reformatory at Ionia. Mich., for the holdup of Mrs. Hettie McCree of Toledo in her cottage at Lakeside, Mich.

He was captured on Christmas eve by Patrolman Frank Richter and Anthony Majschszak after Ferdinand Rosenberger, 2807 Robinwood avenue, had followed the man when he saw him loitering near his home. JUDGE EXPLAINS.

Kriess received his suspended sentence Saturday from Municipal Judge Ramey. The judge said Monday: August Streicher, attorney for Kriess, said he had discussed the case with Police Prosecutor Edward Lamb before it came to trial. Lamb, he said, had agreed not to make state charges against Kriess if he would plead guilty to carrying concealed weapons in police court, where the offense would be only a misdemeanor.

SENTENCE SUSPENDED.

Judge Ramey sentenced Kriess to 30 days in the workhouse and then suspended the sentence.

Judge Ramey made a flat denial that another man, arrested as a suspected companion of Kriess, had been released because of influence by professional bondsmen. This man was Sam Kaplan. He is at liberty on bond on a charge of being a suspicious person and his case has been continued to Jan. 4.

Jewelry valued at about \$1300 was taken in the robbery for which Kriess and a number of companions were sentenced to the Michigan reformatory. Mrs. McCree is the famous invalid Toledo circus rider.

"The testimony in this case was that no gun was found on Kriess, but that a small revolver had been found in the neighborhood where he was captured. The court was informed that Kriess was the sole support of a widowed mother."

The police report of the affair shows that Kriess was captured on Scottwood avenue, after he had been trailed to that neighborhood by Rosengerber, whose wife turned in the police report. Two men were seen by Rosenberger.

POLICE REPORT.

The police report says that the patrolman saw Kriess throw something away as he ran in back of a house at 2915 Scottwood avenue. When Kriess was caught, the report says, he had a flashlight in his possession and admitted having thrown away the revolver as he ran.

POLICE ELECTRICIAN FOUND DEAD IN ROOM

Heart Attack Causes Death of Dan O'Shea, 59.

Dan O'Shea, 59, of 302 Jefferson avenue, was found dead Sunday in his room by Sadie Navarre. O'Shea, who was unmarried, had worked 15 years as an electrician for the police and fire signal division.

Coroner Frank G. Kreft said death was caused by a heart attack. Surviving are his sisters, Mrs. Anna Meyers, 1705 Parkdale avenue, and Miss Minnie O'Shea, Cottage Grove, Wis.

Kestenholtz, a watchman for the Nickel Plate railroad at the Field avenue crossing. said he was struck in the back of the head

SHOOTS INTO GROUP.

Angered by the attack, he said, he drew a revolver and fired one bullet into the air and another into the group of boys.

The bullet struck Ritchic. Screaming in pain, he ran to the home of Fred Sharlow, city policeman. at 629 Hobart street. Sharlow called police and an ambulance took Ritchic to the hospital.

WILL RECOVER.

Other boys in the roup were Ralph Gosline, 15, prother, Eugene, 13, both of 23 Linden place; Clarence Colton, 17, his brother, Carlton 14, 243 Linden place; La Mar Brown, 12, and his brother, Custer, 14, of 909 Walbridge avenue.

Kestenholtz, arrested by Detectives Rowan and Brennan, was unable to tell which boy had thrown the snowball. He was booked on a charge of shooting with intent to kill.

Ritchie's condition is not serious, hospital attendants said.
