NELSON HAS CONFESSED TO MURDER

Told Police that He Killed Bayou.

Said He Saw Him Strike Mrs. Nelson in the Face After Daring Him to Shoot.

Charged with the murder of his wife's cousin, Walter Bayou, Wilker Nelson, held at the central police station for the crime, confessed to the rolice Monday

The confession was taken in writing by Detectives Hall, Daly and Howard and was signed, it is said, by Nelson. The statement follows:

"I returned to my home, 218



Wilker Nelson.

Mitchell street, about 11 o'clock Sunday night with Ernest Frank. I saw Bayou strike my wife in the face and he dared me to shoot him. I did so and we clinched, falling to the porch."

In addition the detectives are said to have secured a statement from Mrs. Nelson. At 1 o'clock Tuesday afternoon, in Coroner Faber's office, the inquest on the death of Bayou commenced.

Nelson, his wife, Frank and other witnesses were present and testifled. It is probable that as the result of the inquest Nelson will be arraigned in police court for murder Wednesday morning.
