A pretty, 20-year-old girl bandit and a man accomplice Monday held up a Kroger store at 1608 Cherry street, bound and gagged the manager, Lawrence Dunn, a clerk and two children, took all the money in a cash register, and fled out Cherry

street.

The girl entered the store first. Nonchalantly brandishing the revolver, she ordered the manager, the clerk and the two children into a corner and commanded them to be quiet.

Her accomplice then entered the store and, as scores traveled up and down Cherry street, the two tied the four so they could not interfere with the robbery.

The girl and man then went thru the cash drawer hurriedly and extracted all the money. An accurate check could not be made directly after the holdup occurred.

Freeing himself and obtaining a revolver, Dunn ran from the store, sighted the holdup pair, and chased them up Cherry street. Police were called and joined in the chase.

#### MONEY UNSATISFACTORY.

After the four had been tied with cord and bound with handker-chiefs, the man and woman opened the cash drawer. They took \$90, and apparently dissatisfied with this amount the woman said to her husband: "Go ahead, shoot 'em'"

The pair fled to their waiting auto and drove out Cherry street. Drumm, freeing himself of his bonds, ran into the street, commandeered an auto and gave chase. Following a zig-zag course which led to Franklin avenue, the bandit machine headed back toward Cherry street in an effort to get out of the city.

#### BANDIT CAR CRASHES.

At the Cherry-Franklin intersection, the bandit auto crashed into and locked bumpers with the auto of Henry W. Kemper, 44, of 419 Indiana avenue. The bandit flashed a revoiver on Kemper, but finding he could not take Kemper's auto, he leveled his gun at Vehon, who was en route downtown and forced him to leave the car.

The bandit pair pushed the child into Vehon's car and drove down Franklin avenue. They were not seen again and it is believed they cut back to Cherry street and left the city by this route.

#### DOG LEFT BEHIND.

Police separated Kemper's auto from the bandit machine and found in the car a furiously-barking wirehaired terrier six weeks old, two suitcases, an overnight bag and a set of West Virginia and a set of Missouri license plates.

In the suitcases were several articles of clothing for the child. a blackjack and several rounds of ammunition, two watches and other wearing apparel.

The man was about 35 years old and was well dressed. The girl, much younger, wore a fur coat.

#### BLAMED IN CRIME SERIES.

At the time of the holdup, the car bore Michigan license plates.

Police said they believed the pair had followed a devious route over several states, holding up stores and changing license plates after each holdup. Ordinarily, it was believed, the woman and child would enter a store and act as foil for the man, who would enter and hold up the store.

A gold pencil and \$3 in cash were taken from Drumm, in addition to the money taken from the cash register.

## BANDITRY DOG'S LIFE, SAYS DESERTED PUP



A bristling, black and white fur bundle from which peered two plaintive eyes—the dog who wanted his master—was left in the abandoned auto of a bandit who Monday held up and robbed a Kroger store at 1608 Cherry street.

# POLICE FAIL TO FIND BANDIT FAMILY CLEW

Man, Woman and Child Escape
After Store Robbery

Police Tuesday said the auto abandoned by a bandit family when it was wrecked as the family escaped after holding up a Kroger grocery at 1608 Cherry street Monday, had failed to furnish clews to the identity of the robbers.

Suitcases and West Virginia and Missouri auto license plates were being checked Tuesday, but police had abandoned hope of capturing the bandits thru these. The auto was stolen Nov. 13 in Wheeling, W. Va. A 6-week-old wire-haired terrier was left behind by the bandits when they wrecked their own machine and forced H. L. Vehon, 155 Islington street, to give them his car.

The bandits, a young woman and a 35-year-old man, left a 4-year-old boy in their car when they entered the Kroger store. They held up L. W. Drumm, 2103 N. 14th street, store manager; Richard Robedeau, 16, of 2255 N. 12th street, a clerk, and Earl Cole, 9, and his brother, Carl, 8, of 717 E. Bancroft street.

### GEN GIRL'S WORK HERE IS CHECKED

#### Two Store Robberies Traced to Daring Gun Girl Selzed in Arizona

Toledo police began a thoro check Wednesday to determine the exact number of holdups staged in Toledo by Mrs. Irene Schroeder and the blond bandit's male companion during their brief but violent career

of banditry in this cit.

The cool-headed gunwoman is known to have taken part in at least two Toledo Kroger store robberies only a few days before the fatal shooting of Corporal Brady Paul, the Pennsylvania state trooper. A number of other holdups were staged in Toledo and nearby towns by a man and a woman about the same time and detectives are making inquiry to determine if any of these could be added to the long list of crimes charged to Mrs. Schroeder and her companions.

#### AIDED IN ROBBERY.

In one of the holdens here, in which the woman assisted in tying up the victims, she urged her man companion to "bump off" the proprietor of the store. This holden was staged while her small son played with his pet puppy in the bandit auto outside the store.

Lawrence Lenfesty. 708 Fernwood avenue, manager of a Kroger store at 1156 Dorr street, which was held up by the couple, Dec. 20, said Wednesday that a receipted bill of the Northwestern Ohio Gas Co., bearing the name of "Meredith Lenfesty" and found in the abandoned bandit car by the officers at Phoenix, was taken from his billfold during the robbery. Mrs. Lenfesty's first name is Meredith.

Lenfesty was waiting on another customer when the man and woman entered his store. The bandits quietly waited until the patron had left and then, with sneers on their faces, drew revolvers. They took \$62 from the cash register and searched Lenfesty's billiold, which contained nothing but the receipted bill. The bandits left Lenfesty bound and gagged in the rear storeroom.

The other holdup occurred two days before Christmas in a Kroger store at 1608 Cherry street. Two customers, a clerk and the manager, L. W. Drumm, were ordered into a rear room and bound by the woman, while the man stood by with a

pistol covering the victims.

When Drumm made a remark to the woman she turned to the bandit and exclaimed: "Why don't you bump this guy of?"

#### CHASES BANDITS.

As soon as they had left, taking \$90 from the cash register, Drumm managed to squirm out of his bonds.

He gave chase to the bandits in his own auto and overtook the fugitives after their car had collided with another auto at Cherry street and Franklin avenue.

As Drumm rushed up, the woman with the utmost self-possession, produced her revolver and held him at bay. Her companion then stopped an auto driven by L. H. Vehon, 155 Islington street, and forced him out of the machine. The 4-year-old boy, who had been left in the disabled bandit auto, was snatched up by the woman and the couple escaped in the stolen car.

#### SHOOT TROOPER.

It is believed that, after this exploit, the couple fled from the city. Four days later they shot Corporal Paul down near Butler, Pa.

When the bandit car was abandoned here, the man and woman left a small black and white puppy. The dog was found by the police and taken to the animal pound.

Toledo police believe now that Mrs. Schroeder's brother, J. W. (Tom) Crawford, may have been the man who took part with her in the Toledo robberies as he apparently had been in Ohio recently. One of the slips found in their car at Phoenix bore the name "J. W. Crawford, Concord, O."

# BANDIT QUEEN, SEIZED BY POSSE IN ARIZONA, ADMITS HER IDENTITY

'Sure, I'm Irene Schroeder,' Says Daring Gunwoman Wanted in Toledo for Robbery/. and in Pennsylvania as Murderess

INDIAN CHIEF TRACKS HER

Bloodhounds Aid in Capture of Woman, Two Men Accomplices in Desert Ravine; Murder Charges Are Filed

PHOENIX, Ariz., Jan. 15 .- Three transcontinental fugitives, one of them Irene Schroeder, "family bandit" leader, fleeing from murder charges in Pennsylvania, came to the end of their trail in jail here Wednesday, the victims of a relentless Indian chief tracker.

The woman, captured in a mesquite wilderness with her two men companions after a running pistol battle with deputy, sheriffs, admitted Wednesday she is wanted in Pennsylvania on charges of murdering a highway patrolman at Butler

Surc I'm Irene Schroeder, but I don't know anything about any killings," she was quoted by Charles Wright.

"One of the men is Glen Dague my husband, and the other is Joe F. Wells, a fellow we picked up in Texas,' she said.

#### FACE MURDER CHARGE.

Wells at first was thought to be J. W. Crawford, Irene Schroeder's brother, but Sheriff Wright said he

believed that Wells was identified correctly as a former Texas convict who was released Christmas day.

My brother is long gone," the woman said, "they'll never catch him."

Pittsburgh authorities telegraphed that the woman, Dague and Crawford are charged with the murder of Corporal Brady Paul, state highway patrolman, after a holdup at Butler, Pa., on Dec. 27.

Sheriff Wright said the woman contended she and Dague were married, altho Pennsylvania reports described Dague as her sweetheart.

#### IRENE EXHAUSTED.

The woman and two men, dusty and almost exhausted after their flight across the country, ran into a barricade of western peace officers in this territory and were brought to the Phoenix jail Tuesday night when they were captured after a battle in the desert near Laveen, a small settlement.

All the ancient and modern methods of man-hunting were brought into play before the trio was captured. First sighted at Chandler, Ariz., the trio shot its way across the desert in front of possemen, kidnaping a deputy, . wounding him and another before they finally were cornered in the underbrush.

#### CHIEF FINDS TRAIL.

Bloodhounds were called from the state penitentiary, airplanes droned over the desert and possemen rode in fast motor cars. Leo Sandust, Pima Indian chief, picked up their trail and followed it relentlessly along a ravine. #### Patrolman Killed On **Emergency Run** To Hospital



#### Driver Arrested

Patrolman Cichy suffered an arm injury and was treated at Mercy Hospital and released. Admitted to the hospital were Mrs. Doss, who

suffered head injuries. Mr. Caudill was arrested on a charge of failing to yield the right-of-way to an emergency vehicle and as a material witness. Bond was set at \$5,000.

The two patrolmen had answered an emergency call at 717 Monroe St., where they found Mr. Odom sitting on the curb bleeding from a knife wound in his throat. En route to Mercy Hospital the

police vehicle collided with Mr. Caudill's car. Both vehicles over-turned after the impact. Patrolman Stevens was thrown from the patrol

Mr. Odom was admitted to Mercy Hospital. William Massey, 20, of 9 North Erie St., where the cutting occurred, admitted wounding Mr. Odom and is being held for investigation in the Safety Bldg., police said.

Patrolman Stevens was appointed to the force March 16, 1922. He won the praise of his superior officers in February, 1946, when he chased and shot a car theft suspect in the 1900 block of Erie St.

Surviving are his widow, Mrs. Marion Stevens; his son, Robert Stevens, and two daughter, Miss Eileen Stevens, a student nurse at Riverside Hospital, and Miss Ruth

The body is at the Worth Clegg Mortuary.

Mr. Doss's body was taken to Bernard Day Mortuary.
